Ms. Julia LoBosco became the Chief, Office of Acquisition and Procurement Law within the Coast Guard, Office of the Judge Advocate General in September 2022. Ms. LoBosco leads a team of attorneys located in Washington, DC and functions as a key leader within a procurement law group totaling 20 acquisition attorneys across the Coast Guard. She advises the leadership of the Coast Guard mission support enterprise regarding contract and fiscal law, legislation, and acquisition policy. Ms. LoBosco is a member of several Coast Guard acquisition and workforce management councils. Ms. LoBosco also is the program attorney for the Coast Guard's Offshore Patrol Cutter, the Coast Guard's top acquisition

priority and largest acquisition in its history. Prior to assuming the role of chief. Ms. LoBosco served as a procurement attorney for 12 years.

Prior to that assignment, she served as a Contract Specialist for the Coast Guard from October 2007 to December 2009.

Ms. LoBosco graduated from Washington College, with a B.A. in Political Science.
